Artificial Insemination AI must be certified by the inseminator at the time of AI. A signed Insemination Certificate from Veterinarian or AI Technician, or a Service Certificate from the stallion owner (if inseminating) are acceptable

The application form is **fully** completed & signed. Forms can be either posted or e-mailed. Emailed forms are preferred

Two clear photos no more than 6 months old, have been emailed 1x left side, 1 x right side of the horse standing without any gear on besides halter or bridle and no hoof black. Photos must show ALL of horse including 4 hooves, eyes, ears, nose & tail.
E-mailed J-Peg photos only accepted as photos are printed directly onto the Registration card. Please include owners name on e-mail

The registration fee is included. Fee can be either paid by cheque or direct credit – ASB bank 12-3013-0256658-00 - Include owners name on direct credit. Direct credit is the preferred method of payment

You are a current member of the NZ Pinto Horse Soc. You must be a member to register a horse

You have viewed "How to Register" on the website "Photo Requirements for Registration"

Once all the correct paperwork, photos & payment is received it takes 2 weeks to be processed. You will then receive a Registration card in the mail. If all paperwork, correct photos, payment etc is not received within 4 weeks of receiving the initial application, paperwork will be returned and a \$10 administration fee will be deducted.
